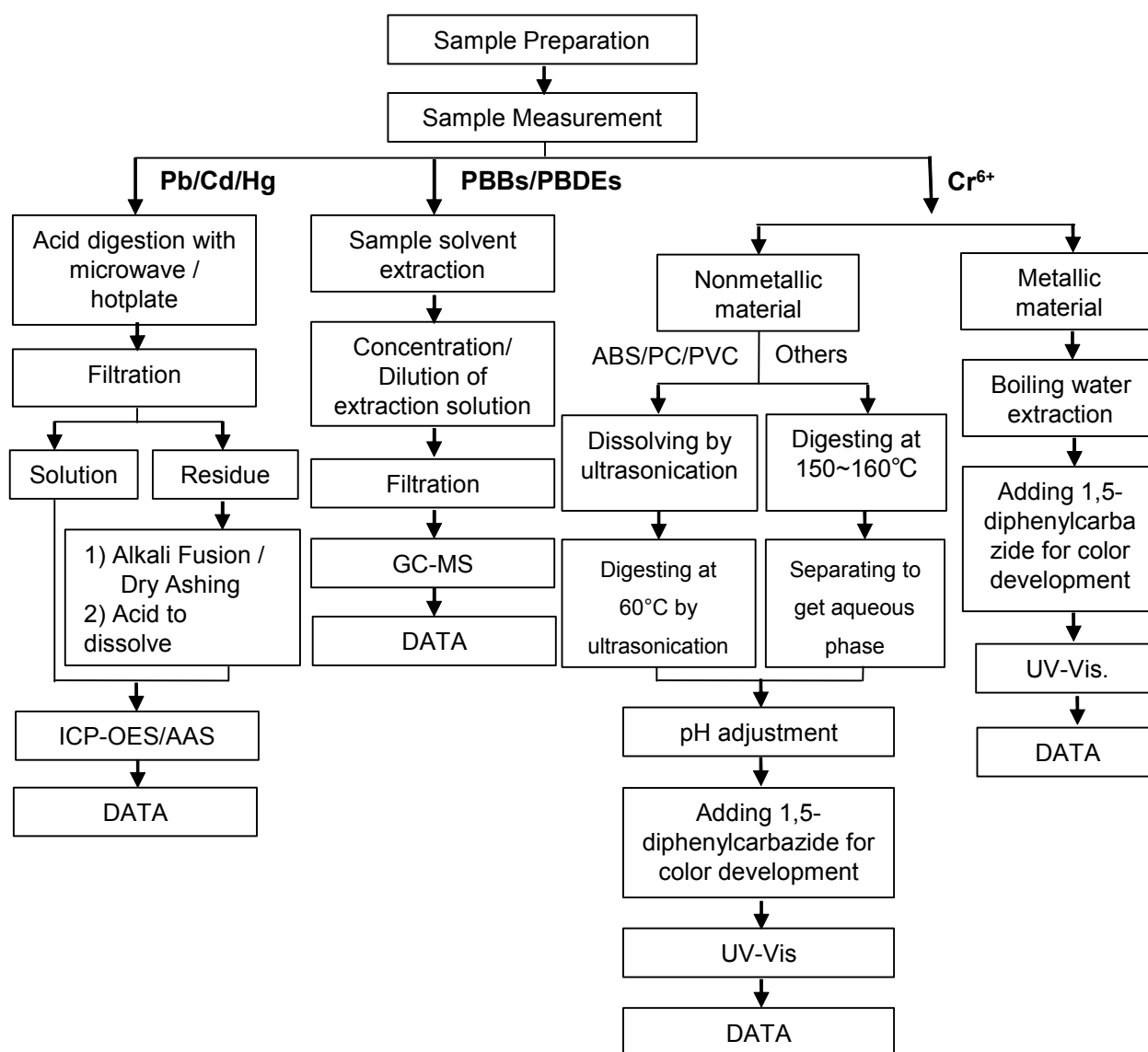

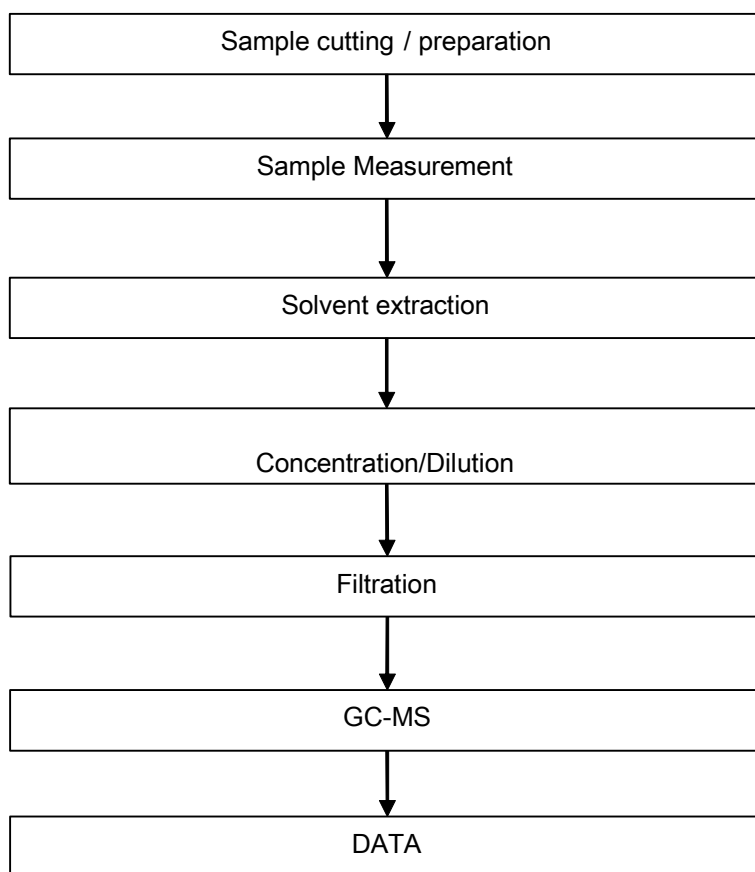
Pb/Cd/Hg/Cr⁶⁺/PBBs/PBDEs Testing Flow Chart

(Cr⁶⁺ and PBBs/PBDEs test method excluded).



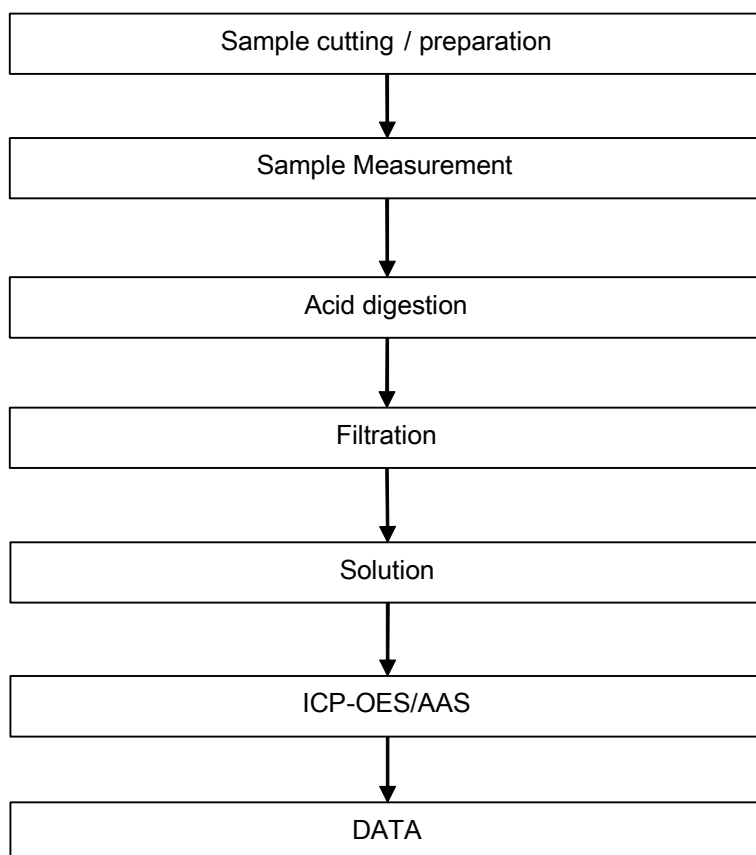
